THE RISE OF THE DIGITAL TECHNOCRACY CONFERENCE RULES

Krakow, September 28-29, 2023

("Statute")

§ 1

Time and duration

- 1. These Regulations define the rights and obligations of the Participants of The Rise of the Digital Technocracy Conference (hereinafter referred to as the "Conference"), which will be held on September 28-29, 2023, stationary in Krakow, at the Faculty of International and Political Studies of the Jagiellonian University, ul. Reymonta 4, 30-059 Krakow.
- 2. The organizer of the Conference is the Jagiellonian University, ul. Gołębia 24, 31-007 Kraków, Institute of American Studies and Polish Diaspora, Faculty of International and Political Studies of the Jagiellonian University (hereinafter referred to as the "Organizer").
- 3. The conference was co-financed from the state budget under the program of the Ministry of Education and Science under the scheme "Excellent Science", under the contract no. DNK/SP/548936/2022 entitled "Organization of an international conference "The Rise of the Digital Technocracy" (hereinafter referred to as "Project"). The co-financing amount is PLN 79,596, the total value of the Project is PLN 109,209.
- 4. Scientific supervision over the course of the Conference is exercised by the Conference Organizing Committee appointed by the Organizer (hereinafter referred to as the "Organizing Committee").
- 5. The Participant of the Conference is any adult natural person with full legal capacity who, no later than July 15, 2023, declared their willingness to participate in the Conference in the manner referred to in § 2 of the Regulations, accepted the rules of participation in the Conference referred to in the Regulations and was qualified to participate in the Conference by the Organizer (hereinafter referred to as the "Participant").
- 6. The Regulations are made available to the Participants on the Conference website https://digitaltechnocracy.uj.edu.pl/ (hereinafter referred to as the "Conference Website"), in Polish and English, in a way that allows them to be downloaded.
- 7. The Organizer reserves the right to change the Regulations due to changes in generally applicable law and the need to adapt the Regulations to this change, in particular in order to adjust the formula of the Conference to the restrictions, orders and prohibitions applicable during it related to the introduction of a state of pandemic or state of epidemic threat, increase funds security of the conferences. The amendment to the Regulations will come into force within 7 days of its publication on the Conference Website. With regard to Participants who accepted the Regulations before making the change, the change will enter into force within 7 days of informing them about the change in the Regulations by e-mail and not expressing objections to this change in the above-mentioned document. deadline.
- 8. The Organizer reserves the right to change the Regulations also in the event of a change in the Regulations that does not adversely affect the rights of Participants or a change consisting in correcting obvious typographical and editorial errors. In this case, the amendment to the Regulations may enter into force within a period shorter than 7 days, but not shorter than 3 days

- from informing the Participants about the change to the Regulations by e-mail and not expressing objections to this change in the above-mentioned document. deadline.
- 9. The Organizer reserves the right to change the date and formula of the Conference in a situation where its conduct on time and in the form referred to in section 1 above will be impossible or excessively difficult for reasons beyond the Organiser's control, in particular due to restrictions, orders and bans related to the introduction of a pandemic or epidemic threat. Changes in the date and/or formula of the Conference will be immediately announced on the Conference Website.
- 10. The Organizer reserves the right to make changes to the Conference program, including the right to change the timetable and the order of presentations. In the event of changes, the Organizer will immediately inform about it on the Conference Website. Changing the Conference program does not constitute a change to the Regulations.

Registration of participation in the Conference

- Participation in the Conference is payable and requires prior registration via the registration form (hereinafter referred to as the "Form") available on the Conference Website, in which the person wishing to participate in the Conference will be required to provide the following data: name and surname, e-mail address, affiliation, academic degree, preferred form of participation in the Conference - active or passive participation, and optionally: restrictions on meals (meat, vegan, for diabetics).
- 2. The detailed method of registering participation in the Conference, registration dates and the amount of the Registration Fee (hereinafter referred to as the "Fee") and the method of payment are provided on the Conference Website.
- 3. A Participant who resigned from participation in the Conference will not be entitled to a refund of the Fee paid by him.
- 4. The Organizer is not responsible for providing incorrect or untrue data by the Participant during the registration of participation in the Conference.
- 5. A maximum of 75 Participants may participate in the Conference. In the first place, applications from active Participants and guests invited by the Organizer to participate in the Conference, including Keynote Speakers, will be accepted. The acceptance of the application for active participation in the Conference is determined by the substantive quality of the abstract submitted in accordance with the provisions of § 5 of the Regulations. Within the limits that will remain after qualifying active Participants, the Organizer will also accept applications of passive Participants based on the criterion of the order of these applications. By June 15, 2023, the Organizer will send an e-mail with information about qualifying or failure to qualify a given person for active or passive participation in the Conference.
- 6. As indicated in sec. 5 above, the number of Conference participants may change due to the epidemiological situation prevailing during the Conference and the related restrictions, orders and bans. The Organizer will immediately notify about the change of limits on the Conference Website and by e-mail. If it is necessary to limit the number of Conference Participants, the Organizer will re-qualify the Participants within the available limits, giving priority to active Participants, and then to passive Participants, in both cases the qualification criterion will be

- the order in which applications are submitted. The Organizer will inform by e-mail the Participants who will not be able to participate in the Conference due to the change of limits.
- 7. The person interested in participating in the Conference, by registering participation, confirms that he/she has read the Regulations and accepts the provisions of the Regulations, which is tantamount to granting the permits, licenses and authorizations referred to in the Regulations, and in the case of an active participant, i.e. a speaker and Keynote Speaker, also with commitment towards the Organizer to conclude a written agreement with him on the transfer of copyrights to the abstract of the lecture/paper and to the lecture/paper referred to in § 6 sec. 9 of the Regulations. Registration of participation in the Conference is made at the time of completing the Participant's data in the Form and sending it along with the consents referred to in § 5-8 of the Regulations, using the registration system on the Conference Website.
- 8. A registered person acquires a place to participate in the Conference after receiving confirmation from the Organizer of qualifying him/her as an active or passive Participant and after paying the Fee. The date of payment of the Fee is the date of posting it to the bank account indicated by the Organiser.
- 9. Failure to pay the Fee by the Participant by July 15, 2023. is tantamount to submitting a declaration of resignation (withdrawal) from participation in the Conference and the inability to participate in the Conference.

General rules of participation in the Conference

- 1. During the Conference there will be plenary discussions with the participation of guests invited by the Organizer, papers (hereinafter referred to as "Papers") of Keynote Speakers invited by the Organizer (hereinafter referred to as "Keynote Speakers") and lectures (hereinafter referred to as "Lectures") by speakers selected by the Organizer from among the Conference Participants, based on abstracts sent by them (hereinafter referred to as hereinafter referred to as "Speakers"). Participants of plenary discussions and Keynote Speakers invited by the Organizer are also required to register their participation in the Conference on the terms referred to in § 2 of the Regulations, excluding the provisions of § 2 sec. 8 and 9 of the Regulations.
- 2. The conference will be held in English. Detailed information and the exact program of the Conference are available on the Conference Website.
- 3. The Participant, after the end of the Paper and the Lecture, may express his will to ask questions. The Organizer, taking into account the planned duration of the Lectures and Papers, as well as the Conference schedule, will decide on the number of questions asked.
- 4. The course of the Conference will be recorded in the form of a photo report (hereinafter referred to as: "Photo report"). The photo report will be published on the Conference Website and in the Organizer's social media (Facebook, Instragram) without time limits for an unlimited group of recipients.
- 5. By making conference materials (hereinafter referred to as "Conference Materials") available to Participants, the Conference Organizer pays special attention to the need for Participants to respect intellectual property rights. Participants undertake to use the Conference Materials made available to them by the Organizer only for their own personal use. Modification, copying, sending, public performance and any use of these Conference Materials for commercial purposes requires prior written consent by the Organizer or by another authorized entity. Participants are fully responsible

- for any damages caused as a result of their behavior contrary to the above reservation.
- 6. Participants accept the established rules of the Conference and its program and undertake not to influence its change and not to disturb the course of the Conference. The Organizer is entitled to exclude from participation in the Conference Participants who violate the provisions of the Regulations, in particular:
 - a) disrupt the course of the Conference;
 - b) take actions that are against the law, decency or detrimental to the legitimate interests of third parties;
 - c) undertake actions aimed at circumventing or indicating an attempt to circumvent the Regulations or the rules of holding the Conference;
 - d) take actions that violate the legitimate interests of the Organizer or harm its image.

Rights and obligations of stationary Participants

- 1. Upon arrival at the Conference venue, the stationary participant is obliged to confirm at the registration desk in the building of the Faculty of International and Political Studies of the Jagiellonian University, ul. Reymonta 4, 30-059 Kraków, your personal participation in the Conference.
- 2. Stationary participants are obliged to comply with the safety rules, health and safety and fire regulations in force at the premises where the Conference is organized and the rules of the sanitary regime in force at that time.
- 3. The Organizer is not responsible for items left and lost during the Conference and for items left in clothing or backpacks/handbags/suitcases, as well as in other public places at the Conference venue, Jagiellonian University.
- 4. In the event of a Participant disturbing law and order and failing to comply with the rules of the sanitary regime in force on the day of the Conference, the Conference staff is entitled to:
 - a) requesting the Participant to behave appropriately;
 - b) demand that the Participant leave the Conference area,
 - c) call the relevant services in a situation where the Participant's behavior qualifies for such intervention, in particular when it poses a threat to other Participants or the Conference staff or the Organizer's property.
- 5. The Organizer is not responsible for events resulting from the Participants' failure to comply with the Regulations, the Participants' failure to comply with the Organizer's recommendations and the instructions of the Conference staff and services responsible for security and order.
- 6. In order to ensure security in the area of the Conference, the Organizer may use monitoring covering the entire area of the Conference, as well as its individual parts. The rules for the use of monitoring by the Organizer are set out in <u>Ordinance No. 34 of the Rector of the Jagiellonian University of May 16, 2019 on</u>: Rules of video monitoring at the Jagiellonian University, as amended, available in the Public Information Bulletin of the Jagiellonian University.
- 7. In the event of noticing a threat to the life and health of the Participants, the Participant is obliged to immediately inform the Conference staff.

§ 5 Lectures, papers

- 1. By registering participation in the Conference via the Form, the Participant may notify the Organizer of his desire to deliver a Lecture (hereinafter referred to as the "Lecture"). Applications are accepted until May 31, 2023, 29:59:59 CET.
- 2. The Participant who declared the will to deliver the Lecture, no later than May 31, 2023, 23:59:59 CET, will send to the Organizer via the Form a digital text file, an original abstract of the Lecture that he intends to deliver during the Conference (hereinafter referred to as "abstract"). By June 15, 2023 at the latest, the Organizing Committee will select the Speakers on the basis of the submitted Abstracts, and will immediately inform the Participants whose Abstracts have been qualified about the positive result of this qualification by sending them a return e-mail by June 15, 2023 at the latest. Further contact aimed at determining the details of the Speaker's speech will take place in a manner agreed by the Speaker with the Organizer.
- 3. When making the decisions referred to in par. 2 above, the Organizing Committee is guided by its own recognition and the need to ensure a high scientific level and thematic diversity of the Conference. The decision of the Organizing Committee is final and does not require justification, the Participants are not entitled to appeal against it.
- 4. By September 15, 2023 at the latest, the Keynote Speakers invited by the Organizer will send the Organizer via the Form a digital text file, an original abstract of the Paper that they intend to deliver during the Conference (hereinafter referred to as the "Abstract").
- 5. Taking the actions referred to in par. 1 4 above, is an expression of granting the Organizer a non-exclusive, territorially, quantitatively and qualitatively unlimited license to use the Abstract, with the scope and fields of use analogous to those referred to in § 6 section 4-7 of the Regulations, with the right to sublicense to third parties with a scope analogous to the scope of the license, for the purpose of making a decision on qualifying the Speaker, preparing, organizing, conducting and settling the Conference, developing Conference Materials and making the Abstracts available on the Conference Website. The said license is granted until the Organizer concludes the agreement referred to in § 6 sec. 9 of the Regulations with the Speaker/ Keynote Speaker. The provisions of § 6 sec. 1-3 and 8 of the Regulations.
- 6. Delivering a Lecture / Paper, as well as granting the Organizer permissions, authorizations and licenses referred to in § 5-8 of the Regulations, for the Use of the Abstract, Lecture / Paper and the image of the Speaker / Keynote Speaker, as well as transferring rights to the Organizer under the agreement referred to in § 6 sec. 9 of the Regulations, to the extent and in all fields of use indicated therein, is free of charge and takes place for the statutory purposes of the Organizer, subject to separate agreements concluded with Keynote Speakers.
- 7. Granting the Organizer the permits, licenses and authorizations referred to in § 5-8 of the Regulations and concluding the agreement with the Organizer referred to in § 6 sec. 9 of the Regulations and the transfer of rights on its basis to the Organizer is voluntary, but necessary to present the Lecture / Paper.

§ 6 Copyright

1. The Speaker/ Keynote Speaker bears full responsibility for the form and content of the Lecture/Paper. The Speaker / Keynote Speaker undertakes to develop and present an original Lecture / Paper and guarantees that the Lecture / Paper will not infringe the rights and personal rights of third parties, contain theses and views inciting hatred or discrimination of any people on racial, cultural, ethnic, religion, ideology or gender. In addition, it is unacceptable to promote ideology and symbolism related to totalitarian regimes in the

- content of the Lecture / Paper, as well as presenting other topics prohibited by generally applicable regulations or violating the good name of the Organizer.
- 2. The Speaker/ Keynote Speaker ensures that he/she will be entitled to full and exclusive proprietary copyrights and rights to the exclusive exercise of derivative rights in relation to the Lecture/Paper and that these rights can be transferred to the Organizer in accordance with applicable regulations, without infringing the rights of third parties or other agreement, and the Organizer will be able to use the Lecture / Paper in accordance with the law and dispose of it without the need to obtain additional consents and licenses, and without infringing the rights of third parties and personal rights.
- 3. Speaker/ Keynote Speaker guarantees that he/she is entitled to use any material necessary to deliver the Lecture/Paper and grant the Organizer a license with the right to grant sub-licences, permits and authorizations referred to in this paragraph and to transfer to the Organizer the rights to the Lecture / Paper in the scope referred to in sec. 9 below, without the need for the Organizer to obtain additional consents and permits.
- 4. The Speaker / Keynote Speaker consents to the recording of the Lecture / Paper by the Organizer or an entity acting on its behalf in the form of Photo documentation.
- 5. Keynote Speaker/Speaker grants the Organizer a non-exclusive, territorially, quantitatively and qualitatively unlimited license, limited in time until the date of conclusion by the Keynote Speaker/Speaker of the agreement referred to in section 9 below with the Organizer, with the right to grant sub-licences with a scope analogous to the license, for the use of the Paper/Lecture including recorded in the form of Photo documentation and, in whole or in part, independently and as part of a collective work, in combination with works and elements freely selected by the Organizer (e.g. with Papers of other Keynote Speakers / Lectures by other Speakers, image and sound, including as part of the so-called Conference Materials), as well as from its studies for information, documentation, education, teaching, popularization scientific knowledge, advertising and promotion of the Organiser, the Ministry of Education and Science and the Conference itself, settlement of the Project, including in particular its use, sharing on the Internet, Intranet, as well as as part of any telecommunications services using any systems and devices, on the Conference Website and in the Organiser's social media (Facebook, Instragram), on the website of the Ministry of Education and Science, on the website www.polona.pl.
- 6. The license referred to in par. 5 above (hereinafter referred to as the "Licence"), is granted to the Organizer at the moment of the Keynote Speaker/Speaker's appearance during the Conference and includes the use of the Paper/Lecture in the following fields of use:
 - a) recording and multiplying the Paper/Lecture in whole or in part by producing copies using any technique, including printing, magnetic recording, all graphic techniques and digital technique;
 - b) trading in copies on which the Paper / Lecture was recorded by placing them on the market, lending or renting copies;
 - c) disseminating through public display, displaying, broadcasting, re-broadcasting, as well as making it publicly available in such a way that everyone can have access to it at a time and place chosen by them, in particular by entering it into computer memory and placing it on the Internet, including a on the Conference website and on the Organiser's social media (Facebook, Instragram), on the website of the Ministry of

- Education and Science and on the website Cyfrowa Biblioteka Narodowa POLONA (at: www.polona.pl);
- d) use by placing/applying on movable or immovable property;
- e) public performance of the Paper/Lecture through its presentation by the Keynote Speaker/Speaker at the place and during the Conference, including in combination with other works, in particular Lectures by other Speakers and Keynote Speakers' Papers;
- f) modifying the Paper/Lecture and making its elaborations in whole or in part, including e.g. the right to correct, make alterations and changes to the entire Paper / Lecture or its individual elements, use and dissemination of derivative works.
- 7. The license also includes the right to exercise by the Organizer and persons acting on its behalf derivative rights to the Lecture / Paper, in all fields of use referred to in section 5-6 above and the right to allow third parties to exercise derivative copyrights to the Lecture / Paper with a scope analogous to that used by the Organizer.
- 8. The Speaker/ Keynote Speaker undertakes not to exercise his/her moral rights to the Lecture/Paper towards the Organizer and the entities authorized by him, in particular the right to the inviolability of the content and form of the Lecture/Paper and its fair use, deciding on the first access to the Lecture/Paper to the public, supervision over the use of the Lecture/Paper and deciding on the method of marking the author of the Lecture/Paper, with the proviso that the Organizer, at the request of the Speaker/Keynote Speaker and, if possible, is obliged to respect the wish of the Speaker/ Keynote Speaker to be marked as the person presenting the Lecture/Paper Paper. The authorization is granted without time, territorial, quantitative and qualitative limitations.
- 9. In connection with the obligations imposed on the Organizer by the Project Implementation Agreement referred to in § 1 section 3 of the Regulations, by September 30, 2023 at the latest, the Keynote Speaker/Speaker will conclude a written agreement with the Organizer under which he will transfer to the Organizer copyrights with the right to exercise derivative rights to the Abstract and the Paper/Lecture, to the extent and in the fields operation analogous to those indicated in sec. 4-7 above.
- 10. In the event of claims by third parties against the Organizer and/or entities acting on its behalf and/or entities authorized by it to use the Lecture/Paper and/or Abstract (hereinafter referred to as the "Authorised Entities"), claims related to the Lecture / Paper and/or Abstract or their individual elements, Speaker/ Keynote Speaker:
 - a) release the Organizer and/or the Authorized Entities from the claims in question, to the extent to which it was obliged to acquire from third parties the rights to the legally protected elements of the Lecture/Paper and/or Abstract, including copyright and related rights to them and their individual elements, exercise derivative rights and obtain from them the permits and authorizations referred to in this paragraph and
 - b) shall be fully liable for any damages suffered by the Organizer and/or Authorized Entities as a result of making claims against them referred to in point a) above, including primarily, but not exclusively, for damages related to claims for damages for unlawful use of the Lecture/Paper and/or Abstract or unlawful use of their individual elements.,

- The Organizer will record the course of the Conference using devices recording the image in the form of Photo documentation - for educational, didactic, information, documentation purposes, popularization of scientific knowledge, advertising and promotion of the Organizer, the Ministry of Science and Education and the Conference itself, settlement of the Project, archiving.
- 2. The Participant (including the Speaker and the Keynote Speaker) by declaring in the Form their willingness to participate in the Conference, expresses unlimited in time, territory, quantity and quality, consent to the use of his image for the purposes indicated in section 1 above, without the right to remuneration for the above, in particular by recording the Participant's image in the Photo documentation and using this recording, processing, duplication and multiple dissemination of the Participant's image recorded in the above-mentioned manner without the need to approve them each time, in particular in the scope and in an analogous manner to the one referred to in § 6 section 4-7 of the Regulations, including in particular on the Conference Website and in the Organizer's social media (Facebook, Instragram), on the website of the Ministry of Education and Science, on the website www.polona.pl .
- 3. The Participant (including the Speaker and the Keynote Speaker) is aware that the Photo Report from the Conference will be made available on the Internet and will be available on the Conference Website https://digitaltechnocracy.uj.edu.pl/ and in the Organizer's social media (Facebook, Instragram), for an unlimited number of people, without time limits, and may also be made available on the website of the Ministry of Education and Science and on the website www.polona.pl.
- 4. In connection with the use of the image, the Participant (including the Speaker and the Keynote Speaker) will not exercise the right to control and approve the use of the image each time, including the right to approve the final form of the Photo documentation in which it was used and the right to indicate it each time as a person featured in Photo documentation, and in particular, indicating his name and surname.
- 5. The Conference may be photographed in the form of Photo documentation only by the Organizer. It is forbidden to record and take photos by the Participants during the Conference without the Organizer's prior consent.
- 6. The Organizer has the right to authorize other entities to use the image on the terms set out in this permission.

§ 8 Processing of personal data

According to Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation hereinafter referred to as "GDPR"), the Jagiellonian University informs that:

- administrator of the Participant's personal data is the Jagiellonian University, ul. Gołębia 24, 31-007 Kraków, represented by the Rector of the Jagiellonian University.
- 2. The Jagiellonian University has appointed a Data Protection Officer , ul. Czapskich 4, 31-110 Krakow. The Inspector can be contacted by e-mail: iod@uj.edu.pl or by calling 12 663 12 25 from Monday to Friday, from 8:00 to 15:00.
- 3. The Participant's personal data will be processed in order to:

- a) performance of the contract, the subject of which is participation in The Rise of the Digital Technocracy Conference, as well as for the purpose of registering participation in the Conference, accepting applications from Participants ready to deliver a Lecture and Keynote speakers ready to deliver a Paper, i.e. pursuant to art . 6 sec. 1it. b GDPR, i.e. on the basis of an agreement concluded by accepting the Regulations. The conference, organized on September 28-29, 2023 by the Jagiellonian University, the Institute of American Studies and Polish Diaspora and the Faculty of International and Political Studies, will be held on-site.
- b) carrying out Photo documentation for documentation, information, educational and didactic purposes, advertising and promoting the Organizer and the Conference itself, settlement of the Project, archiving with regard to personal data of Participants in the form of an image pursuant to art. 6 sec. 1 lit. f GDPR.
- c) ensure the security of the Conference in accordance with the Rules of video monitoring in force at the Jagiellonian University available at https://bip.uj.edu.pl/ and the information obligation regarding image processing in video monitoring available at https://iod.uj.edu.pl/ video surveillance pursuant to art. 6 sec. 1 lit. e GDPR - in relation to video surveillance data
- 4. Providing by the Participant the personal data indicated in point 3 lit. a is necessary to conclude a contract, participate in the Conference, prepare an Abstract and deliver a Lecture / Paper. Providing personal data in the field of image is voluntary. With regard to the data referred to in point 3 lit. c above is voluntary, but failure to provide them due to the obligation to ensure the safety of Participants results in the inability to participate in the Conference.
- 5. The Participant's personal data may be made available to entities authorized to receive them on the basis of generally applicable laws and institutions financing and settling the project.
- 6. The recipients of the Participant's personal data are entities providing IT and organizational support in the organization of the Conference including the entity providing software used to register participation in the Conference.
- 7. The Participant's personal data will not be transferred to third countries (outside the European Economic Area) or to international organizations.
- 8. The Participant's personal data will be stored for the period of organization of the Conference and until the final settlement and closing of the Conference, as well as until the statute of limitations for claims that may arise from the performance of the contract referred to in section 3 lit. a), and to the extent indicated in par. 3 lit. b) above until an objection is raised. Video surveillance data will be processed for a maximum of 3 months.
- 9. The Participant's personal data provided in the Registration Form will not be disclosed to third parties.
- 10. The Participant's personal data in the form of an image may be recorded in photos from the Conference used to create a Photo documentation and processed on the Conference Website (https://digitaltechnocracy.uj.edu.pl/), on the MEiN website, on the Organizer's websites and social profiles and on university channels in social media (in particular Facebook, YouTube, Twitter, Instagram), in a manner that allows access by third parties, for information, documentation, educational, didactic, advertising and promotion purposes of the Organizer and the Conference itself, as well as archiving, including for the needs of relations from the Conference in accordance with § 7 of the Regulations.

- 11. If the Participant has expressed a desire to deliver a Lecture / Paper, his personal data voluntarily indicated in the content of the Lecture / Paper will be processed on the Conference Website for information and documentation purposes.
- 12. The Participant has the right to: obtain information on the processing of personal data and the rights granted in accordance with the GDPR, access to the content of their data and rectification, as well as the right to delete personal data from the administrator's files (unless further processing is necessary to comply with a legal obligation or in to establish, pursue or defend claims), and the right to limit processing, transfer data, object to processing in cases and under the conditions specified in the GDPR.
- 13. The Participant's personal data will not be subject to automatic decision-making or profiling.
- 14. The participant has the right to lodge a complaint with the President of the Office for Personal Data Protection if it is considered that the processing of your personal data violates the provisions of the GDPR.

Final Provisions

- 1. These Regulations are made available to Conference Participants on the Conference Website and enter into force on the day of its posting on the above-mentioned website. page.
- 2. The Organizer will immediately inform about the cancellation of the Conference on the Conference Website. The Organizer will not be obliged to any compensation or damages to the Participants, including the Speakers and Keynote Speakers, or to reimburse the costs incurred to participate in the Conference, except for the reimbursement of the Fee.
- 3. In matters not covered by the Regulations, generally applicable provisions of Polish law shall apply.
- 4. The Regulations are available in two language versions Polish and English, in the event of discrepancies in interpretation, the Polish version shall prevail.
